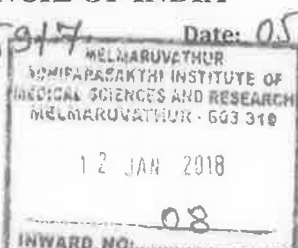

Sub: Recognition/ approval of Melmaruvathur Adhiprasakthi Institute of Medical Sciences & Research, Melmaruvathur for the award of MBBS degree (150 seats) granted by the Tamilnadu Dr. MGR Medical University, Chennai u/s 11(2) of the IMC Act, 1956.

Sir,

I am directed to inform you that in compliance of the Order dated 08/09/2017 passed by the Hon'ble Supreme Court in Writ Petition (Civil) No. 680 of 2017 filed by Melmaruvathur Adhiprasakthi Institute of Medical Sciences & Research Vs. Union of India and Ors., an assessment of the physical and other teaching facilities available for recognition/ approval of Melmaruvathur Adhiprasakthi Institute of Medical Sciences & Research, Melmaruvathur for the award of MBBS degree (150 seats) granted by the Tamilnadu Dr. MGR Medical University, Chennai u/s 11(2) of the IMC Act, 1956 was carried out by the Council Assessors on 13th & 14th November, 2017. The assessment report (13th & 14th November, 2017) was considered by the Executive Committee of the Council at its meeting held on 14/12/2017 and it was decided as under:-

"The Executive Committee of the Council considered the assessment report (13th and 14th November, 2017) in pursuance of the order dated 08/09/2017 passed by the Hon'ble Supreme Court in Writ Petition (Civil) No. 680 of 2017 filed by Melmaruvathur Adhiprasakthi Institute of Medical Sciences & Research Vs. Union of India and Ors and decided to recommend to the Central Government for recognition/approval of Melmaruvathur Adhiprasakthi Institute of Medical Sciences & Research, Melmaruvathur for the award of MBBS degree (150 seats) granted by the Tamilnadu Dr. MGR Medical University, Chennai u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 03.01.2018.
